#### Master curriculum description:

Managing the security risks of natural disasters is a problem that is increasingly faced by the world public and increasingly addressed by governments, specialized non-governmental agencies and intergovernmental organizations. In countries where frequent, natural disasters slow down sustainable development, they reduce quality, but also create risks for the development of new threats (poverty, unemployment, crime, the shadow economy, conflicts, terrorism, etc.). Natural disasters are not everyday events, which is why they require unusual reactions. Hence the routine methods of governmental institutions, businesses, the non-governmental sector and citizens are no longer sufficient in the face of natural disasters. These entities must acquire specialized knowledge and skills in natural disaster research, risk assessment, modelling and simulation of natural disasters, use of modern information and communication technologies in risk management natural disasters, all within the national and international legal framework and within the protection and rescue system. This knowledge and skills are offered within the master program -Natural Disasters Security Risk Management. So, the purpose of this study program is the acquisition of academic knowledge and skills for managing the security risks of natural disasters.

The main objective of the study program is to enable students to apply scientific and professional achievements in solving security problems, protection of human health, tangible goods and natural values, for the development of a system for managing the security risks of emergencies arising from natural disasters as well as the application of acquired knowledge. The specific goals of the study program are to acquire the necessary knowledge and skills for:

- security risk analysis and emergency management of natural disasters;
- analysis of cause and effect relations and solving problems of security risks, protection of human health, environment and material goods in natural disasters;
- development of research methodology and methods of managing the safety risks of natural disasters;
- developing strategies, designing and managing security systems in the assessment, preparation, response and recovery of natural disasters;






