Training description:	

The participants of the training were introduced with the types of natural disasters as well as the causes of their occurrence. Special attention was given to natural disasters that most often affect Kosovo*. In addition, the participants were introduced with direct and indirect consequences occurred due to natural disasters. During the training there was a discussion regarding the modern methodology used for natural disaster risk assessment and risk management.

Measures and activities, which need to be undertaken for prediction, prevention and mitigation of consequences, occurred due to natural disaster were also discussed.

The aim of the training was to enable the members of the protection / rescue / civil protection structures of the city / municipality, company and other legal entity to be able to timely and efficiently carry out the tasks of protecting and saving people, material and other goods endangered by natural disasters.

Participants were introduced with the following:

- the definition of natural disasters and the types of disasters
- the types of natural disasters that most often affect for Kosovo* area
- how to behave during and after the disaster occurs
- is it possible to predict natural disaster and what are the prevention measures that must be undertaken to mitigate the consequences
- which structures should be involved in the defense from natural disasters
- how to mitigate the consequences of natural disasters
- actions in emergencies.




