# Responses and overall summary

#### Number of responses

#### Description

This report details the responses to the Annex T questionnaires completed by NATRISK partners individually within July and August 2018.

Similar to the last evaluation, in general, project partners reported having few significant issues with the internal quality of the project. The response rate of participants was slightly higher this year of 76 compared to the 66 from last year. Overall the average of all responses was 4.67 in close comparison to the 4.63 average of 2017 and each statement average ranging from 4.03 to 4.89 (2017 this was 3.71 to 4.86).

Similar to last year the section which scored the lowest was the Implementation of the Special Mobility Strand. Although comparatively to other sections this scored lower, the average was still just above 4 and had shown an improvement from last year. More details on this is discussed in the relevant section below.

The management team is aware of the difficulties and has a strategy for promoting the implementing the Special Mobility Strand activities and this will be discussed in more detail at the Chania meeting in September 2018.

# Results of evaluation of the structure of the project


#### Description

The structure of the project continues to be well received by project partners with very high scores being reported across all of the categories; a large majority of respondents grading it as excellent. Compared to the other questions two scored a bit lower "I know about all the partners' tasks in the project" and "the work process is quite clear to me"; although these still mainly received scores of very good or excellent. Project management will look to provide additional information about all partner activities and how these fit into the work process to ensure that all are kept informed.

#### Results of evaluation of implementation of the project activities


#### Description

#### Results of evaluation of dissemination


#### Description

Positive responses were also reported in relation to dissemination with the majority of respondents rating the project as Very Good or Excellent. Although still scoring highly, the final statement "the Project is well presented in the media" scored a little worse than the other two categories, so ideas will be sought from project partners how this might be improved.

All respondents reported Very Good or Excellent scores related to project exploitation illustrating few concerns.



#### Results of evaluation of Special Mobility Strand implementation

#### Description

The highest percentages of respondents for this section were in the Excellent or Very Good category. However, this section was the lowest scoring and needs consideration in more detail. Scores for the first to statements "I am well informed about the Special Mobility Strand" and the "Special Mobility Strand activities are well planned" were a little bit lower than the averages for other sections, however still relatively high and have all improved since the last Internal Quality Report.

The final statement is the one which scored lower than the other ones: "Your participation in Special Mobility Strand". Although the average is still greater than 4, 4% of respondents reported is as being Poor. In part this might be explained by the nature of the question, not all respondents will have (or be expected to) participated in SMS activities and therefore the statement may not be as applicable for all respondents. Indeed this statement had the lowest response rate of all the questions (n=69) with some leaving it blank as "not applicable". Others may have scored it lower because they have not participated in the SMS.


A more important related question is whether it has scored lower because respondents have wanted to participate, but have not been able. The SMS is a key point for discussion at the Chania project meeting in September 2018.
