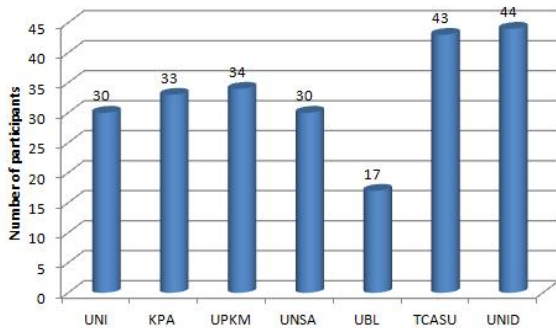

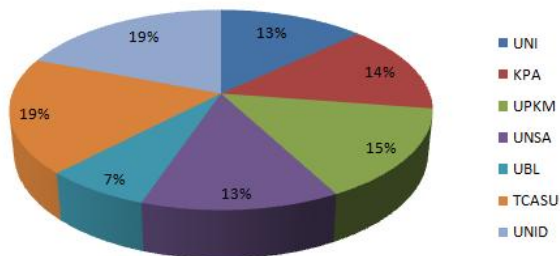

# REPORT ON IMPLEMENTED SECOND TRAINING FOR CITIZENS AND PUBLIC SECTOR

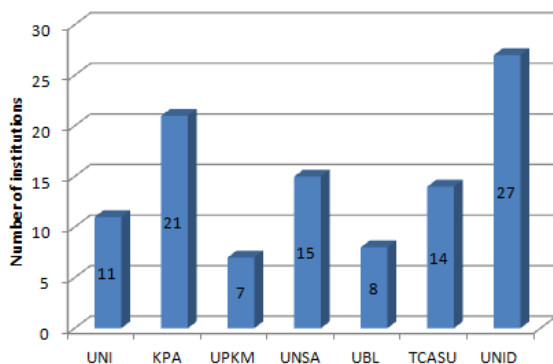
During the seven trainings, 231 participants or 21 participants more than planned in project proposal were trained from 103 different institutions in the field of natural disasters risk management.



Number of participants per WB HEI



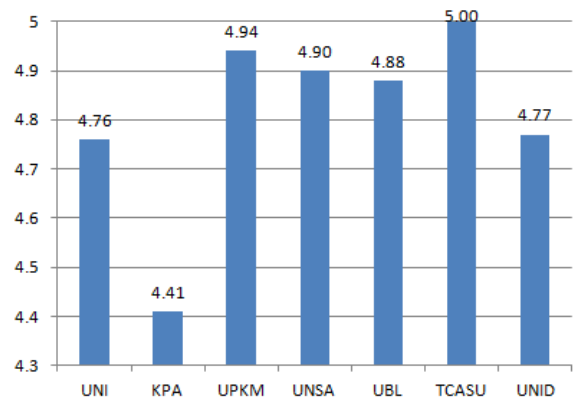
Percentage of trained persons per WB HEI



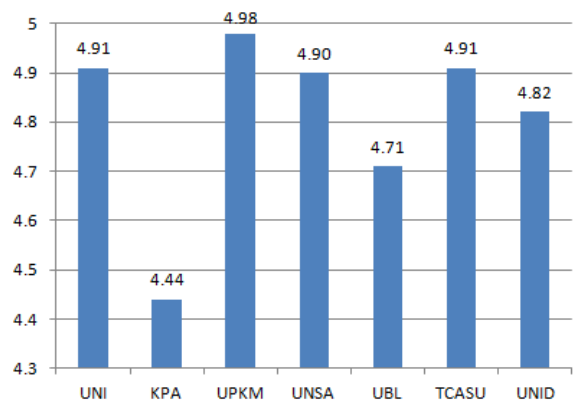
Number of different participated institutions per WB HEI

After organized trainings, WB HEIs prepared self-evaluation report of training for citizens and public sector according to the received

evaluation lists. Evaluation list for self-evaluation of trainings contained three groups of questions classified as 1) general organisation of the training (11 questions), 2) general participant expectations (7 questions) and 3) evaluation of trainer (6 questions).

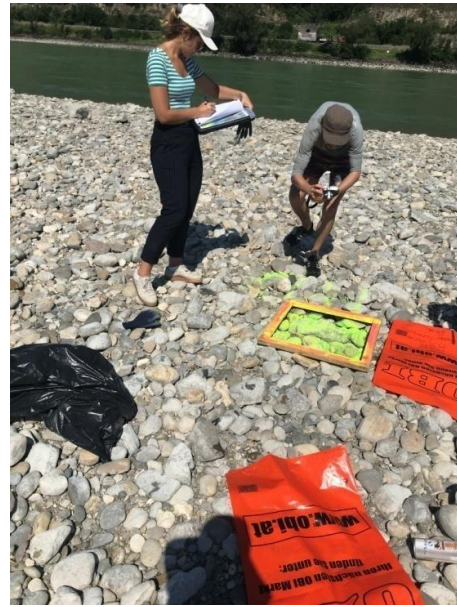
## JOINT MEETING WITH BESTSDI PROJECT
